Water system updates

Water Department update - Mark

- Well 17A inspection on Friday (DEP), will go online as soon as they pass
- Received draft design for WTP on CJC Hwy – new site
- Scheduling carbon change-out for March to help with THM – will require plant to be offline for 10 days but 17A should be online by then
- Draft study for storage water tanks – GZA Tom Sexton
- Lots of leaks and frozen pipes
- Dolan wells – still waiting on design and location from Weston & Sampson
- Reservoir Project – Still trying to schedule meeting to discuss next steps for FEIR (Becky)

Brown water update – None

Prep for Town Meeting

The ask was finalized last night:

- On warrant as debt exclusion (will go on to water rates if it doesn't pass)
- ARPA funds to be used for the project – 5.5 mill minus 250k to be held aside for anything else that might come up (such as helping small businesses with covid relief)
